Dear Customer,

We inform you that to comply with restrictions defined by art. 4 of Directive 2011/65/EU of the European Parliament and of the Council of 8 June 2011 (RoHS II), LU-VE S.p.A. has established an internal process based the harmonized European standard EN IEC 63000:2018.

Based on the currently available information, we inform you that the products supplied by LU-VE S.p.A. comply with the requirements defined by art. 4 of the RoHS directive with respect to the content of the substances listed in Annex II of the directive.

This declaration is referred to Annex II of RoHS II as amended by Delegated Directive (EU) 2015/863. Thus, the maximum tolerated concentrations in the homogeneous materials are:

- Hexavalent Chromium (0,1 %)

- Benzyl butyl phthalate (BBP) (0,1 %)
- Dibutyl phthalate (DBP) (0,1 %)
- Diisobutyl phthalate (DIBP) (0,1 %)
